#### Rae Binder-Hathaway, Pl

Rae is a Development Economist and Behavioral Scientist with over 14 years of international development experience at the intersection of gender equality, behavioral economics, international development and program evaluation. She has developed Behavioral Economics programs on behalf of the Australian, Bosnian (BiH), and Nigerian governments, and currently works as a Gender Specialist with UNDP (HQ). Previous roles include Behavioral Scientist/Gender Specialist with UN Women and The World Bank; lead manager of J-PAL's global training vertical (MIT), and as a Behavioral Research Fellow for Harvard's Women and Public Policy Program. She holds an MPA from The Harvard Kennedy School of Government.
